## SAFE

- Secured an emergency egress route for Westwood Hills (design in 2025, construction in 2026) and advanced a community connector to improve evacuation capacity.
- Advocated for a region-wide Subdivision Egress Review to identify communities needing secondary emergency routes, with early priorities flagged for the 2026 Capital Budget.
- Strengthened wildfire resilience by securing \$20,000 in additional support for FireSmart™ Community Cleanups, making vegetative debris disposal safer and more accessible.
- Advanced the integration of wildfire CO<sub>2</sub> emissions and forest-loss accounting into HalifACT, ensuring HRM tracks wildfire as a standalone climate hazard and recognizes forest loss as reduced carbon sequestration.

## CLEAN

- Launched the 1K for \$1K Litter Pickup Challenge to support community cleanups while fairly distributing District Capital funds, empowering community groups, schools, nonprofits, and sports organizations to earn \$1,000 by picking up litter from 1 km of District 13's roads, parks, beaches, or trails.
- Partnered with Divert NS and the Great Nova Scotia Pick-Me-Up to provide free cleanup kits (safety vests, gloves, bags) and free/waived tipping fees at Otter Lake.
- Advanced and passed a motion at Council for a comprehensive HRM litter strategy focusing on commercial and industrial debris.
- Committed to continuing the program in 2026, with community litter pickups also counting toward FireSmart™ volunteer hours.



## THRIVING

- Submitted a motion for a staff report on on-demand transit for areas outside the urban service boundary, including communities like Prospect not serviced by other rural transit providers.
- Advocated for improved park-and-ride facilities and expanding daytime/weekend routes and schedules for transit, and flexible service models to grow economic opportunity and enhance affordability for residents.
- Moved a motion to hire 10 additional firefighters in 2025 to strengthen HRM's emergency response capacity.
- Supported Council's investment in 14 new RCMP officers, including 6 for Halifax West, improving response times and strengthening community policing in District 13.



## HEALTHY

- Advanced the community vision for Hackett's Cove Park by coordinating site walks and consultations on accessible paths, kayak access, picnic areas, and low-impact design.
- Continued support for West Dover's baseball field revitalization, securing a new land lease and improving long-awaited recreation infrastructure.
- Supported Bay SailAble at the St. Margaret Sailing Club with District Capital funding, to advance their free, inclusive sailing opportunities for individuals with physical, cognitive, mental, or emotional challenges.
- Advanced HRM's Rural Active Transportation Program for Hubbards alongside the Hubbards Streetscape Project, with new multi-use paths and sidewalks prioritized along Trunk 3 to enhance safety, accessibility, mobility, and village connectivity.
- Invested \$22,000 in the Whites Lake Legion for a generator to maintain Comfort Centre operations during emergencies.
- Supported restoration efforts at St. John's Anglican Church in Peggy's Cove, preserving an important historic, cultural, and community landmark.



## DISTRICT 13 SNOW REMOVAL

Here's what you need to know about snow removal in District 13, including which roads are municipal, which are provincial, and what timelines you can expect for plowing.

### Upper Tantallon, Stillwater Lake, Hubley, Head of St. Margaret's Bay, Boutiliers Point & Lewis Lake

These communities fall under municipal responsibility for snow clearing. Here are the priority levels and timelines:

#### Priority 1 Roads

Main arterial roads, emergency routes, Halifax Transit routes, and roads with steep grades

- Clearing begins: After 2 cm of accumulation
- Completion: **12 hours** after the end of the storm
- Surface: Bare pavement

#### Priority 2 Roads

Residential streets and gravel roads

- Clearing begins: After 10 cm of snowfall
- Completion: 24 hours after the end of the storm
- Surface: Snow-covered but passable

### Communities Along Highway 333 & Ingrampoint → Hubbards

Roads in these areas are provincial roads, meaning snow removal is handled by the Province of Nova Scotia. For updates and reporting:

## EXTENDED PRODUCER RESPONSIBILITY REGULATIONS

Starting Dec. 1, Nova Scotia transitioned to an enhanced recycling system managed by Circular Materials, a not-for-profit organization that is committed to growing an efficient and effective recycling system. What does this mean?

- Your curbside collection day/schedule and requirements for placement (i.e. blue bags) will stay the same.
- You'll be able to recycle the same materials, no matter where you live across the province.
- You'll be able to recycle more materials than ever before, including hot and cold beverage cups, deodorant, toothpaste tubes, frozen juice containers and ice cream tubs, to name a few!
- Recycling and collection questions will continue to be addressed by the Halifax Regional Municipality.
